Inclusion of MOOCs through SWAYAM/NPTEL and Skilling based Courses in the Curriculum from A.Y. 2024-25

Ref.:

GTU has adopted the inclusion of SWAYAM/NPTEL MOOCs courses vide AC MOM dated 7th November, 2020. All institutes affiliated with Gujarat Technological University (GTU) apply for an Extension of Approval (EoA) to All India Council for Technical Education (AICTE). During the EoA filling process for the Academic Year 2024-25, a crucial consideration is the incorporation of Massive Open Online Courses (MOOCs) through SWAYAM/NPTEL and 'Skilling' based courses offered by 'Skill India' and 'Ministry of Skill Development and Entrepreneurship' in the curriculum. It is informed to all institutes to mention 'YES' in the questions related to above mentioned topics in the EoA process.

Aligned with the National Education Policy (NEP) 2020, Gujarat Technological University has initiated the process of revising the curriculum for the Engineering, Management, Computer Applications, Architecture and other disciplines at Diploma, Undergraduate, Postgraduate and Master level. These revisions shall be implemented from the Academic Year 2024-25. The updated curriculum shall incorporate provisions of NEP-2020 to include MOOCs and 'Skilling' based courses as per AICTE and UGC guidelines adhering to the specified credit limits.
